# **Biographical Information**

#### **Agency History**

The Alabama Congress of Parents and Teachers (ACPT) was chartered in Montgomery in 1911 as the Alabama Branch of the Nation Congress of Mothers and Parent-Teacher Associations. In 1924 the organization became known as the Alabama Congress of Parents and Teachers. In 1970 the Alabama Congress of Colored Parents Teachers merged with the Alabama Congress of Parents and Teachers. As a part of the National Congress of Parents and Teachers, the ACPT is a volunteer organization engaged in educating parents and teachers on issues affecting children youth and supports public education and the welfare of children. Detailed historical information is available in Fanny Mitchell Nelson's "Through the Years" with the Alabama Congress o Parents and Teachers, vol. 1, 1911-1946, Box 17, and in the folders "History of ACPTA, 1911-1985" and "History of ACPTA 1969-1971," in Box 13.

# Scope and Contents

Records of the Alabama Congress of Parents and Teachers, (1914,1929 -1995, bulk, 1929-1995) including presidents' annual (1949-1951, 1956-1957, 1984-1987) and correspondence (195 Board of Directors' correspondence (1969-1971, 1988-1989) minutes (1931-1993), and pre convention minutes (1976-1979, 1986 -1990); Executive Committee correspondence (1962-1989) and (1936-1991); bylaws (1937-1989); committee reports (1943audits, budgets, and financial information (1946-1983, 1989 - 1991); annual conventions (1914-1995, bulk, 1939-1995); scrapbooks (1938-1939, 1957-1963); photographs (1968, 1979, 1984); and clippings.

Subject files include information on the founding and history of the ACPT; Alabama Congress of Colored Parents and Teacher 1987, bulk 1966-1972); conferences; integration; local units; membership; the National Congress of Parents and Teachers scholarships; summer institutes and workshops; and social affecting children such as drug abuse, teenage pregnancy, violence on television. Also included is biographical information on PTA Presidents Mary Haislip; Elizabeth Baldwin Hill (d.1960); Ann S. James; Sally Mitchell; Fanny Mitchell Nelson; Arthur Mae Norris (b. 1912); Winnie Mae Schaffner; and Helen Talbot
